Bike Store / Change Rooms / Locker Room

TERMS AND CONDITIONS OF USE

- Access to the End of Trip facility is provided to authorised users only.
- Allendale Square Management agrees to allow you to use the End of Trip facilities for the intended purpose on the condition that you comply with these Terms and Conditions, obey all posted notices and take due care not to damage the facility.
- Failure to comply with these directions may result in you being excluded from use of the facility.
- All authorised users of the End of Trip facility enter and use the facility at their sole risk and release the owner of Allendale Square and its employees, contractors and agents from all liability in respect of :-
 - a. Loss of or damage occasional to property left in the Premises or in or about the facility.
 - b. Injury to or death of any person
- No food or drink to be left within the EOT facilities, including inside the lockers, at any time.
- Bicycles are not to be taken into the passenger elevators.
- Access into and out of the facility must be via the Sherwood Court entry.
- All cyclists must obey signposted 10KPH speed limit within the car park.
- All cyclists must follow the designated Green shared lane.
- Cyclists must dismount to negotiate the turn at the cable gate.
- Bicycle shoes and cleats **MUST NOT** be worn within the Allendale Square lobby.
- All persons must vacate the end of trip facilities immediately on the activation of the fire alarm signal.
- The Unisex Locker room is not to be used as a change room.
- CCTV monitoring is installed in the Unisex locker room for security and safety of all patrons.
- Clothing, towels and footwear are not to be left exposed in the facility but can be hung in the dryer or placed in the lockers. Any clothing left out will be collected, place in a lost clothing box and disposed of within 30 days.
- Bicycle locks are not to be left on the bike rack but can be left on the lock rails which have been provided for this purpose. Locks left on the bike racks will be removed and disposed of.
- The bicycle racks are intended for short-term storage of bicycles only. Management reserve the right to dispose of any bicycle that is considered abandoned in the facility.
- Bicycles that have not been used or moved for three months will be considered as abandoned.
- Lockers in the Unisex Locker Room will unlock every night at 9pm. Any articles left in lockers may be collected by Management and disposed of.
- Lockers in the bathrooms will unlock every Friday night at 9pm. Any articles left in lockers may be collected by Management and disposed of.
- Lost swipe access passes must be reported immediately to Centuria management.

- Replacement for a lost or damaged passes will be charged at the standard building rate and must be ordered through the users company.
 - Instructions on how to use the bike racks are located within the bike cage.
 - Management reserves the right to close the facilities without notice to undertake repairs and maintenance necessary for the functioning of these facilities.
 - Management reserves the right to amend the Terms and Conditions without notice and terminate your agreement for the use of the facility if the Terms and Conditions are not adhered to.
